Sub: Prevention of Ragging in the University.

We have declared our University as a No-Ragging University. It is brought to the notice of all students, faculty, staff and other stake holders that our university has adopted the guidelines issued by University Grants Commission, New Delhi for curbing the menace of ragging in the University and affiliated Colleges. The State Government has also enacted the Haryana Prohibition of Ragging in Educational Institutions Act, 2012. The provisions of this Act shall apply to all the Institutions.

- 2. In this connection, an Anti-Ragging Committee with Prof. Ravinder Vinayek, Dean Academic Affairs as Chairman has already been constituted. Telephone number 01262-393575, Mobile No. 09416052184 email ID:r_vinayek@rediffmail.com
- An Anti-Ragging Flying Squad with Prof. S.P. Khatkar, Proctor as Chairman has also been formed. Telephone number is 01262-266665, Mobile 09813805666 and e.mail ID: s_khatkar@rediffmail.com
- Students having any distress should lodge their complaints, if any, to the Chairman, Anti Ragging Flying Squad.
- 5. Provost (Boys) and Provost (Girls) shall ensure through their Wardens and other faculty and staff deputed for duty in hostels for prevention of ragging in the hostels. Telephone numbers of Provost Boys is 9416321444 and Provost (Girls) is 9896091448. They shall also ensure that the contact nos. of the Provost/Warden are displayed on the Notice Boards of the Hostels. They shall immediately address the complaints of the students and forward the same to the Chairman, Anti-ragging Flying Squad for redressal.
- 6. An affidavit must be obtained by the Heads of the Departments from every student and his parents as per **Annexure 1 and II**. No student shall be allowed to attend classes unless this affidavit has been furnished by him to the Head of the Department concerned.
- 7. Dean Students Welfare shall ensure that suitable hoardings / bill boards / banners at prominent places within campus are erected to exhort the students to prevent or not to indulge in ragging. The names of officials and their telephone numbers be mentioned who can be contacted in case of need.

- Director, Computer Centre shall arrange the film on anti ragging from the UGC and copies of the same be sent to all Heads of Departments for screening the same in classes.
- 9. All faculty members and staff shall be on the vigil, report and take remedial action for prevention of ragging in and outside the campus so that this social evil is completely eradicated.
