Late bids will not be considered. Any tender received after deadline for submission of Tender prescribed by the MD University Rohtak shall be rejected.
- The bidders must quote rates and other terms and conditions for all the equipment's/items failing which tender will be rejected. Total cost of the Quotation will be one of the important deciding factor while deciding the Quotation in favor or against any bidder.
