Sub: Admission to B.Ed.(R) course for the session 2009-10 and direction of the Hon'ble Punjab & Haryana High Court Chandigarh.

Sir/Madam,

I am directed to inform you that the Hon'ble Punjab and Haryana High Court, Chandigarh passed an order on 17.9.2009 in CWP No. 11272 and 11287 of 2009 that unfilled seats after the final counseling to be conducted by the M.D. University shall be allowed to be filled-up by the respective recognized/affiliated colleges at their own level after 30/9/2009 in the following manners:

- a) The concerned college will issue a public notice notifying unfilled seats available with it after allocation in the final counseling by the University. This notice shall be published in two national news papers, one English and one vernacular having wide circulation between 01/10/2009 to 3/10/2009. These seats shall be offered, firstly, to the applicants who have applied for counseling/admission to the University. counseling/admission to fill up the seats from the applicant who have already applied to the University shall be held from 4/10/2009 to 7/10/2009. The unfilled seats after providing opportunity to the applicant shall be filled up from the non applicant. This condition shall be notified in the same public notice. The counseling/admission will be open to both non resident and the resident of Haryana State and will be held from 8/10/2009 to 12/.10/2009.
- b) No admission shall be made by any college thereafter not withstanding the availability of the seats in any of the College in the State of Haryana.
- c) The college will make admission on the basis of the inter-se merits of the non-applicant who may seek admission pursuant to the public notice issued by the Colleges.
- d) The college will not charge any extra fee, other than the fee prescribed by the University/Government.
- e) The fee shall be deposited by the candidate in accordance with the norms /procedure already prescribed by the University/Government
- f) It will also be notified in the public notice that the student who will be granted admission will deposit the fee within one week from the date of

admission in accordance with the norms/procedure prescribed by the University/Government in this regard.

- g) The affiliating University shall nominate one representative to be associated in the process of counseling/admission by each of the College. Such nomination shall be made before the date notified hereinabove for counseling/admission by the Colleges. If the respondent University fails to nominate its representative or if the nominated representative fails to approach the college concerned, the college may proceed to hold counseling/admission in the absence of such representative with prior intimation to the respondent University in this regard.
- h) All the Colleges after making admission will submit a list of admitted candidates along with their details and merit position to the respondent University within a period of 10 days from the date of such admission and the respondent University shall have the right to conduct scrutiny in accordance with the norms/procedure laid down by it.

You are, therefore, requested to comply with the above orders of the Hon'ble High court strictly and faithfully.
