Sub:Fees of B.Ed Regular Programme for the year 2009-10

Sir/Madam,


I am directed to inform you that the State Fee and Admission Committee as per letter No.18/170-2007 UNP (IV) dated 11th August 2009 received from the Higher Education Commissioner, Haryana, Panchkula has decided that the Education Colleges in the State of Haryana will charge the prescribed fee for B.Ed Regular Programme for the session 2009-10 in four equal instalment. As students to be admitted will report in the College from 17th August 2009 onwards, they are required to deposit the fee within the prescribed time. Therefore, on direction of the State Fee Committee, the University has decided that the Colleges will charge the fee as per schedule given below:-

1. At the time of Admission : Rs.10000/- + Rs.3900/- University charges
2. 2nd Instalment from : Rs.10000/-
1st October to 10th October
3. 3rd Instalment from : Rs.10000/-
1st January 2010 to 10th January
4. 4th Instalment from : Rs.8500/-
1st April-2010 to 10th April

The above fee shall be charged from the students only through Bank, for which the students shall be issued challan form in triplicate (one for Bank, one for college and one for student). The college should therefore open an account in Bank for this purpose.

If at any stage any College is found to be violating the above instructions strict disciplinary action like debarring for admission for a particular session or withdrawal of affiliation shall be taken. A copy of the above letter is also enclosed for your ready reference and compliance.

A meeting of the Committee constituted by the State Government of Haryana for fixation of fees, headed by Justice N.C.Jain (Retd.), for B.Ed.course in private self-financing colleges in the State was held on August 7th, 2009.

It has been observed by the Committee that charging of fees for B.Ed.course by the private self-financing institutions in one lumpsum instalment is creating hardships for large number of students. The Committee has accordingly taken the following decisions for strict compliance:-

- (i) The fees for the B.Ed.course should be charged in four equal quarterly instalments w.e.f.the new academic session 2009-10.
- (ii) The fees from the students should be taken only through banks. For this purpose all self-financing B.Ed.colleges should open bank accounts and issue appropriate fee receipts to the students for charging fee in four quarterly instalments.

You are requested to ensure strict compliance of the above decisions of the Fee Committee. Wide publicity should be given to these decision by issuing public notice as well as informing the institutions and the students at the time of the counseling for admission in B.Ed.course.

The Universities are requested to also constitute a mechanism for ensuring the strictest enforcement of these decisions and also for taking action against the institutions which deviates from it.
