4. An undertaking to be submitted by the candidate anti ragging (Specimen enclosed).
5. Fees (in cash only) approximately Rs.10, 000/- approximately which will be deposited on the same day in the Bank after verification of documents and allotment of seat.
6. Candidates attending counseling without documents and/or fee will not be entertained.

5. I hereby affirm that, if found guilty of ragging, I am liable for punishment according to Clause 9.1 of the Regulations, without prejudice to any other criminal action that may be taken against me under any penal law or any law for the time being in force.

6. I hereby declare that I have not been expelled or debarred from admission in any institution in the country on account of being found guilty of abetting or being part of a conspiracy to promote ragging; and further affirm that, in case, the declaration is found to be false, I am aware that my admission is liable to be cancelled.
