NOTIFICATION

All the Colleges are also required to submit the NAAC accreditation certificates at least letter Grade-B, if the same has not yet been submitted with the University. Further as per new norms of the NCTE, all the Colleges are also required to submit the fresh recognition letter from

the NCTE regarding their revised intake of the existing course(s) and also complete the other requirements.

All the Colleges of Education, are, therefore, required to complete the deficiencies/ shortcomings/ conditions mentioned in the summary proforma, the Inspection Report and also mentioned above and send compliance for the same within above stipulated period for necessary verification, if required. In case any Institution fails to submit the compliance report by the above stipulated date, the process of extension/continuation in provisional affiliation shall not be started till the deficiencies for the session 2014-15 are completed and the admissions to such colleges for the session 2015-16 shall also not be allowed in any case and disciplinary proceedings for withdrawal of provisional affiliation shall also be initiated as per University rules.
