Minutes of the meeting held on 12.2.2015 at 5.00 PM under the Chairmanship of Hon'ble Chief Minister, Haryana- Review of Aadhaar Project in State of Haryana.

उपरोक्त विषय के संदर्भ में।

विषयाधीन मामला में दिनांक 12.2.2015 को मुख्यमंत्री महोदय हरियाणा की अध्यक्षता में हुई अधिकारियों की बैठक में Aadhaar Project in State of Haryana बारे बैठक हुई थी। इस बैठक के Minutes में निम्नलिखित 2 बिन्दु आप सभी से सम्बन्धित हैं:-

- 1- Emphasis may be made to cover the left out population especially in the age group 0-6 years (approx.24 lac) Identification of left out population is to be done by DCs through Aanganwaari workers, Panchayat secretaries. PS WCD will take necessary action in this regard. For covering students in Educational Institutes, PS School Education and PS Higher Education will take necessary action. Village level campaign will be planned by the DCs besides block level and district level mega camps.
- 2- State would use Aadhaar Platform for implementation of different state Schemes Aadhaar should be seeded in all the schemes being run in the State so that a database can be prepared with Aadhaar as the unique identity. All these data will be integrated. SRDH to be strengthened and to be extensively used. Aadhaar Column should be inserted in all the registrations/ applications forms for various Govt. benefits. Aadhaar details may be captured in the digitized data at the time of admissions in schools/colleges.
