22. Qualifications for appointment of Professor, Associate Professor and Assistant Professor for M.Ed. course in Education Colleges

Considered the recommendations of the Academic Council made vide Reso. No.15 of its meeting held on 27.11.2012 that the following qualifications prescribed by the NCTE be adopted for appointment of Professor, Associate Professor and Assistant Professor for M.Ed. Course in Education Colleges:

**Professor:**

- (i) Master's Degree in Arts/Humanities/Sciences/Commerce and M.Ed. each with a minimum of 55% marks  
OR  
M.A.(Edu.) with 55% marks and B.Ed. each with a minimum of 55% marks
- (ii) Ph.D. in Education and
- (iii) Atleast 12 years of teaching experience in University Department of Education or College of Education of which a minimum of 5 years at the M.Ed. level with published work in the area of his specialization.

**NOTE:** In the event of non-availability of eligible and suitable candidates for appointment as Professor/HOD/Reader as per above eligibility criteria, it would be permissible to appoint retired Professor/HOD/Reader in Education on contract basis for a period not exceeding one year at a time till such time the candidates complete 65 years of age.

**Associate Professor:**

- (i) Master's Degree in Arts/Humanities/Sciences/Commerce and M.Ed. each with a minimum of 55% marks or its equivalent grade  
OR  
M.A.(Edu.) and B.Ed. each with a minimum of 55% marks
- (ii) Ph.D. in Education and
- (iii) Atleast 8 years of teaching experience in University Department of Education or College of Education of which a minimum of 3 years at the M.Ed. level with published work in the area of his specialization.

**Assistant Professor:**

- (i) Master's Degree in Arts/Humanities/Sciences/Commerce and M.Ed. each with a minimum of 55% marks or its equivalent grade  
OR  
M.A.(Edu.) and B.Ed. each with a minimum of 55% marks and
- (ii) Any other stipulation prescribed by the UGC/Affiliating Body/State Govt. from time to time for the positions of Principal and Lecturers shall be mandatory.

**NOTE:** It is desirable that one faculty member possess Master's Degree in Psychology and another member in Philosophy/ Sociology besides M.Ed.
