3. All the candidates are required to bring original documents(such as certificate of Matriculation, +2, Character certificate from the last attended School/ Institutes, Haryana Domicile Certificate and certificate relating to reservation, if any).
4. An Anti Ragging undertaking to be submitted by the candidate (Specimen enclosed).
5. Fees (in cash only) approximately Rs.40, 000/- which will be deposited on the same day in the Bank after verification of documents and allotment of seat. No fees will be charged from SC candidates whose parent's income is less than two lacs and fifty thousand. Such candidates are advised to bring proof of income certificate at time of counseling.

I hereby declare that I have not been expelled or debarred from admission in any institution in the country on account of being found guilty of abetting or being part of a conspiracy to promote ragging; and further affirm that, in case; the declaration is found to be false, I am aware that my admission is liable to be cancelled.
