Subject:- Proposal for celebration of National Science Day (NSD)-2015

Please refer to the subject cited above.

As you are aware that National Science Day is observed on 28th February every year. Similarly, the day will also be celebrated during the year 2015. The theme of the National Science Day for the year 2015 is "Science for Nation Building".

You are requested to send the proposal in the enclosed proforma for celebration of National Science Day-2015 in your university and also circulate this letter among the colleges under the jurisdiction of your university. The concerned colleges may be requested to send the proposal directly to this office, duly signed by the Principal. The proposal in the prescribed proforma should be submitted to this office **by 21st January, 2015**. It is also mentioned here that merely submitting a proposal does not mean that funds are sanctioned.

The National Science Day celebration should preferably be spread over a month and even up to two months culminating or beginning on the National Science Day. The best way to celebrate this occasion is to generate awareness amongst the stakeholders about the importance of informed decision making on a range of emerging issues of immediate concern to the community. Keeping in view the theme in mind, the proposal could involve one or more of the following interactive activities-developing colourful and interesting displays on walls of educational institutions, S&T exhibitions, popular lectures, demonstrations based on the theme, popular science especially chemistry slide-shows, debates/quiz/essay competitions, mock parliament for college students, seminars, symposia with scientists and engineers and in general activities involving participation by large numbers of people, especially children and women, and aimed at nurturing of a scientific temper among them.
