Sir/Madam,

I am directed to inform you that requests for increase of seats for admission to various courses are being received. The matter has been considered by the Committee constituted by the Vice-Chancellor to resolve all admission related issues and it has been decided that the issue be considered by the Departmental Committee and in case the Departments feel that seats be increased, then a proposal indicating the number of seats to be increased in the course(s) being run in your Department be sent to this office by 31.8.2015 positively, failing which it will be presumed that you are not in favour of any increase in number of seats.

Further, there is the following provision in the Prospectus, Page 56, Clause 2 for qualifying the entrance test for admission:

"2. The candidates must secure at least 25% (5% relaxation for SC candidates of Haryana only) marks in Entrance Test to be eligible for admission to those courses for which admissions are made through entrance test. If seats remain vacant, the above requirement of marks can be relaxed upto 5% marks by the Vice-Chancellor on the recommendations of Head of the Department concerned. No further relaxation in any case shall be permissible

This matter has also been considered and it has been decided that if at the time of 3rd counselling, seats are available and candidates with above percentage of marks are not available, the Heads of the Departments may at their own level lower down the percentage i.e. 20% (19% for SC candidates of Haryana) and admissions be made accordingly.

If needed, the required number of seats be deemed to have been created and the details of such candidates/seats be sent to the Academic Branch.
