4. An undertaking to be submitted by the candidate anti ragging (Specimen enclosed).
5. Fees (in cash only) approximately Rs.12, 000/- approximately which will be deposited on the same day in the Bank after verification of documents and allotment of seat.
6. Candidates attending counseling without documents and/or fee will not be entertained.



I hereby declare that I have not been expelled or debarred from admission in any institution in the country on account of being found guilty of abetting or being part of a conspiracy to promote ragging; and further affirm that, in case, the declaration is found to be false, I am aware that my admission is liable to be cancelled.
