Sub: **Admission to Ph.D Programme/Award of University Research Scholarships**

Sir/Madam,

I am directed to inform you that the Vice-Chancellor under Section 9-A(5) of the M.D.University Act has been pleased to amend Clause 4,5,6,7,8,10 and 12 of the Ph.D Ordinance as per Annexure A. These amendments shall be applicable for admissions to the Ph.D Programme from the current session 2015-16.

A common entrance test for Ph.D Programme for the subjects in Life Sciences (except Food Technology, Forensic Science and Environmental Science) will be held and application forms for such subjects will be submitted in the Centre for Bio-Technology.

A query regarding submission of additional application in the allied subjects has been considered and it has been decided that such candidates shall be required to have the additional application form and fill up such form for maximum 4 courses with an additional fee of Rs.100/-for each additional form alongwith original form with fee of Rs.500/-. Since there is a common entrance test the candidates shall not be required to deposit additional entrance fee in such cases. The forms of such candidates who qualify the test, will be forwarded to the concerned Department for necessary action.

Further, at page 12 against date 24 September 2015 (time 2.00 p.m. to 3.15 p.m) of the prospectus be read as Computer Science and Engineering in place of Electronic & Comm. Engineering.

The University Grants Commission has given clarification regarding qualification of supervisor, vide its letter D.O. No. F.10-6/2011 (PS) Misc. Dated 6th July 2015 as under:

"University shall allocate the supervisor from amongst the regular faculty members in a department or its affiliated PG Colleges/Institutes depending on the number of students per faculty member, the available specialization among the faculty supervisors and the research interest of the student. It is further clarified that any Ph.D/M.Phil degree awarded by a University under the supervision of a supervisor who is not a faculty member of the University or its affiliated PG Colleges/Institutes would be in violation of UGC (Minimum standards and procedure for award of M.Phil/Ph.D) Regulations 2009"

Therefore, in the light of the above, you are requested kindly to inform the final number of seats for admission to Ph.D Programme in the courses being run by the Department by 1.10.2015. A corrigendum to this effect will be issued separately.

CORRIGENDUM

The following amendments have been made In the Prospectus and Ordinance for Admission to Ph.D Programme /Award of University Research Scholarships for the Session 2015-16 :

1. The word 'Ph.D Course' be read as 'Ph.D Programme'
2. In Clause 5.1 'Admission Procedure' month of June/July be read as month of July/August.
3. The required pass percentage in entrance test for SC/ST candidates be read as 47.5%
4. Note (ii) (c) at Page 8 be read as under:-
 - (ii) (c) The candidates who have passed the Pre-Ph.D/M.Phil Course of M.D.University, Rohtak
5. The weightage at page 17, in Clause 3(c) be read as under:-
 - (i) 30% marks of the percentage of marks in the entrance test.
OR
 - (ii) Weightage of 25 marks to those candidates who have qualified for JRF
OR
 - (iii) Weightage of 20 marks to those candidates who have passed NET or its equivalent test.
OR
 - (iv) Weightage of 15 marks to those candidates who have passed SLET (State Level Eligibility Test)/M.Phil/Pre-Ph.D examination of M.D.University, Rohtak
6. The words "from amongst the teachers of the concerned Faculty" be added in Clause-6 (h) of the Ordinance.
7. The words "The whole process of holding the meetings of the Departmental Committee, Departmental Research Committee and the PGBOS shall be completed within 3 months of the last date of receipt of application for each cycle." be added in the clause 8(viii)(b).
