Dear Sir / Madam,

The Government of India is implementing, e-Panchayat, a Mission Mode Project for e-enablement of Panchayats. Under this, ten web-based Applications have been developed that address various aspects of panchayat's functioning. The data from these applications are displayed on Geographic Information System (GIS). The aim is to develop a country-wide Gram Panchayat/equivalent level spatial data infrastructure to improve service delivery at Panchayat and for better governance. The following points are to be implemented:

- Panchayati Raj Institutions could be assisted by the Geography Departments for capacity building and hand holding.
- The academia must give emphasis on selection of rural local bodies as areas of interest for academic projects and also collaborate with students and professor for developing readily replicable models,
- Students may be encouraged to actively participate in the Gram Sabha meetings and contribute to the discussion therein.


