Sub: **3rd Counselling for URS/Pre-Ph.D/M.Phil.- Conversion of seats**

Sir/Madam,

I am directed to inform you that in view of the provision under point 10 at page 72 and point 14 at page no.73 of the Information Brochure 2013-14, the matter has been considered by the Vice-Chancellor who has been pleased to pass the following orders:-

1. That all the candidates reporting for 3rd counseling shall mark their attendance from 10.30 a.m. to 11-00 a.m. Candidates reporting late shall not be entertained.
2. That all the candidates who could not appear for the 1st and 2nd counseling be also allowed to participate in 3rd counseling.
3. That the seats reserved for different categories will be first offered to the candidates of the concerned reserved category and if any seat of reserved category remains vacant, the same may be converted into Haryana General Category by the concerned HOD and the same will be filled up strictly on the basis of merit. However, if any candidate of reserved category comes for admission during counseling, he/she will be considered first for admission. Even if seats remain vacant the same may be filled on All India Basis after conversion.

Further action regarding creation of additional seats, if any for the candidates who have been awarded JRF may be taken as per letter No.AC-1/2013/19085-19122 dated 17.10.2012 (already issued) A copy of the same is, however, again enclosed.




Sub: Admission of candidates awarded Junior Research Fellowship in

Sir/Madam,

It is to inform you that some candidates have been awarded JRF by UGC and as per guidelines issued by the University Grants Commission such candidates must get themselves registered for M.Phil./Ph.D. at the first available opportunity but not later than a period of 2 years from the issue of Eligibility Certificate by UGC/CSIR etc.

In view of above guidelines issued by the UGC, all JRF awarded have to take admission in M.Phil./Pre-Ph.D. course. The matter has been considered by the Vice-Chancellor and has ordered that all such candidates be allowed admission either in M.Phil. or Pre-Ph.D. course who are JRF awarded. If seats are not available, the same may be got created in phased manner within two years and admissions be made on merit of all such candidates.
