**22. Amendment in the Common Ordinances of Undergraduate, Postgraduate and 5-Year Integrated Courses (Semester System)**

Considered the recommendations of the Academic Council made vide Reso. No. 6 of its meeting held on 29.04.2014 that the Common Ordinances of Undergraduate, Postgraduate and 5-Year Integrated Courses (Semester System) be amended as under to be applicable with effect from the session 2014-15:

**1. Common 5 year Integrated course:**

Existing	Proposed
<p>Clause-12 A candidate shall be treated as promoted to the next semester/class automatically subject to fulfilment of conditions as laid down in Clause-9 above unless detained from appearing in an examination on any genuine grounds.</p>	<p>Clause-12  xx      xx      xx  However, promotion to 7<sup>th</sup> semester will be allowed only when he/she has cleared the 1<sup>st</sup> Module (1<sup>st</sup> to 6<sup>th</sup> semesters).</p>

**2. Common 2 year (PG) courses:**

Existing	Proposed
<p>Clause-12 (ii) The candidate shall be treated as promoted to the next semester/class automatically subject to fulfilment of conditions as laid down in Clause-8 above.</p>	<p>Clause-12 (ii) The candidate shall be treated as promoted to the 2<sup>nd</sup> and 4<sup>th</sup> semester automatically but for promotion to 3<sup>rd</sup> semester, he/she must clear 50% papers of 1<sup>st</sup> semester, subject to fulfilment of conditions as laid down in Clause-8 above.</p>

**3. Common 3 year (UG) courses:**

Existing	Proposed
<p>Clause-11 (ii) The candidate shall be treated as promoted to the next semester/class automatically subject to fulfilment of conditions as prescribed in Clause-7 above.</p>	<p>Clause-11 (ii) The candidate shall be treated as promoted to the 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> semester automatically but for promotion to 3<sup>rd</sup> semester, he/she must clear 50% papers of 1<sup>st</sup> semester and for promotion to 5<sup>th</sup> semester, he/she must clear 50% papers of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> semesters taken together, subject to fulfilment of conditions as laid down in Clause-7 above.</p>
