Sub: **For not charging any fees / funds from SC students at the time of admission .**

Sir/Madam,

I am directed to inform you that letter No.3/18-2008 Sch.(2) dated 09.01.2014 received from the Director General, Higher Education, Shiksha Sadan, Sector-5, Panchkula was sent to you for taking further action vide Endst.No.AC-V/2014/660-1259 dated 15.01.2014. Taking into consideration and to avoid confusion, the Vice-Chancellor in anticipation of approval of the Executive Council has approved the following amendments in Section-A (University Teaching Departments) and Section-B Affiliated Colleges- (Arts, Science and Commerce) of Ordinance relating to Tuition fee and Hostel fee etc.

Existing	Proposed
At the time of admission, fee/fund like enrolment, registration, tuition fee, sports, Union, Library, Magazine, Medical, Examination fee and other funds may not be charged from the SC students whose parents annual income is not more than Rs.2 lacs. The claim on account of such fee may be submitted to the Higher Education Commissioner, Haryana, Panchkula after getting the same vetted from the Auditors of the Directorate for reimbursement.	At the time of admission, fee/fund like enrolment, registration, tuition fee, sports, Union, Library, Magazine, Medical, Examination fee and other funds may not be charged from the SC students whose parents annual income is not more than <b>Rs.2.5 lacs</b> . The claim on account of such fee may be submitted to the Higher Education Commissioner, Haryana, Panchkula after getting the same vetted from the Auditors of the Directorate for reimbursement. The affiliated Colleges shall however pay all the University dues at the time of submitting the registration return/examination form as usual.
	<b>Provided that the Self Financing Colleges / Self Financing Institutions run by the University are not bound to follow. Provided further that the aided affiliated Institutions / University Teaching Departments running courses on self financing basis are bound to follow. Instructions received from the State Government from time to time on this issue shall be followed.</b>

Further, Section A(ii) of the Ordinance which relates to Hostel Fee for students studying in University Teaching Departments has also been amended as under:-

				5. Any fees prescribed by the University for hostel residents belonging to SC category shall be borne by the students concerned. But such students shall be paid maintenance allowance by the State Govt.as per scheme(s) notified by the State Government from time to time.

उपरोक्त विषय पर इस निदेशालय के पत्र क्रमांक 3/18-2008 छा0(2) दिनांक 03.12.2009, 10.12.2009, 04.10.2012, 08.10.2013 एवं 06.11.2013 की निरंतरता में।

उपरोक्त संदर्भित पत्र के अन्तर्गत विभाग द्वारा यह निर्देश दिए गए थे कि प्रवेश के समय academic courses में पढ़ने वाले अनुसूचित जाति के छात्रों से जरूरी फीस/फण्डस जैसे कि enrollment, registration fee, tuition fee, games, union, library, magazine, medical/examination व अन्य जरूरी फण्डस (जो संबंधित विश्वविद्यालय से अनुगोदत है) न लिये जाये। इसके अतिरिक्त Hostel से संबंधित जो भी फीस संस्था द्वारा ली जानी है वह छात्र द्वारा स्वयं वहन की जानी है, परन्तु Hosteller छात्रों को निम्न अनुसार maintenance allowance स्कीमानुसार दिये जायेंगे:-

सभी देय भुगतान स्कीमानुसार अवार्ड रोलस प्राप्त होने पर जांच उपरान्त निदेशालय द्वारा reimburse किए जाएंगे। परन्तु विभाग के ध्यान में लाया गया है कि फीस/फण्डस न लेने बारे दिये गये आदेशों की पालना पूरी तरह से नहीं की जा रही है। अतः पुनः अनुरोध है कि उपरोक्त आदेशों की पालना दृढ़ता से की जाए अन्यथा विभाग आपकी संस्था के विरुद्ध अनुशासनिक कार्यवाही करने के लिए विवश होगा।

हरियाणा राज्य में चल रहे स्वः पोषित डिग्री कॉलेज/विश्वविद्यालयों के स्वः पोषित संस्थान/ शिक्षण संस्थान उक्त दिशा निर्देश मानने के लिए बाध्य नहीं है परन्तु जिन अराजकीय अनुदान प्राप्त महाविद्यालयों/विश्वविद्यालयों के विभागों में सेल्फ फाईनांसिंग बेसिस पर जो Courses चल रहे हैं उन पर पूर्ण रूप से जारी दिशा निर्देश लागू होंगे। कृप्या तदनुसार कार्यवाही करें।
