The supply shall be subject to the terms and conditions given below:

- The sealed quotations, complete in all respects, must reach the University Librarian, Vivekananda Library, M.D. University, Rohtak- 124001 (Haryana) latest by 07.03.2012 by 3.00 p.m. The tenders will be opened on 07.03.2012 at 3.30 PM in the Office of University Librarian. The quotees or their authorized representatives will be allowed at their own costs to be present at the time of opening of quotation.
- Tender documents, costing Rs.1000/- (non-refundable) can be purchased either by cash payment from the office of the undersigned or can be downloaded from our website <http://www.mdurohtak.ac.in>.
- The tender filed on the basis of Notice downloaded from website must be accompanied by a Demand Draft of Rs. 1000 (non-refundable).
- The bank draft should be drawn in favour of the Finance Officer, M.D. University, Rohtak, payable at Rohtak. Bank Draft payable at any other place shall not be accepted.
- The quotation received after due date and time or incomplete in any respect shall be liable to be rejected.
- The quotation must be valid for a period of at least three months from the date of its opening.

- 7. All costs / charges must be quantified and spelt out in clear terms. Non-quantified costs/charges shall not be considered and paid.
- 8. The delivery of the material shall be FOR Vivekananda Library, M.D. University, Rohtak.
- 9. The security / earnest money equivalent to 2% (two percent) of the total value of the bid, rounded off to nearest Rs.100.00 (Rs. hundred only) in the shape of "Deposit at Call or Fixed Deposit Receipt", drawn in the favour of the Finance Officer, M.D. University, Rohtak, is mandatory and must accompany the quotation failing which the quotation will not be considered. The security / earnest money in other shapes, viz., Demand Draft / Pay Order / Cheque shall not be accepted. Earnest money of the unsuccessful bidders shall be returned.
- 10. The successful bidder has to deposit performance guarantee equal to 10 % of total cost of the supplies in the form of Bank Guarantee/FDR etc. during the warranty period. EMD amount will be returned subsequently.
- 11. Earnest Money shall be forfeited if the supplier backs out after the placement of order. Other actions such as blacklisting, recovery of loss, if any, can also be taken.
- 12. The payment terms shall be as under :
 - a. The Supplier shall raise the bills after the supply of material and satisfactory installation. The University shall make the payment within 30 days from the date of bill submission, if the bill(s) is/are found in order and inspection report satisfactory.
 - b. Service Tax and any other statutory tax / cess / levy shall be deducted at source as per Rules prevalent at the time.
 - c. Costs/charges not mentioned in the quotation/tender shall not be paid.
 - d. Bank charges, if any, shall be borne by the supplier.
 - e. Road tax, octroi etc. shall be paid by the supplier.
- 13. The quotees must append the following documents with the quotation:
 - a. Copies of PAN / TAN.
 - b. Copies of Sales Tax Number along with latest Sale Tax clearance certificate.
 - c. Copy of Service Tax Number
 - d. List of clients along with complete addresses and telephone numbers.
- 14. Quantity of goods may increase or decrease as per requirement.
- 15. The goods, which are not found according to specifications, and are thus not accepted, shall be lifted back by the supplier at his own cost/risk.
- 16. Damage to goods or any other loss due to accident etc. during transit shall be the responsibility of the supplier.
- 17. Goods shall be accepted subject to satisfactory installation/assembly report of the Inspection Committee / Committee of Experts.
- 18. During evaluation of the quotations, the Purchase Committee may, at its discretion, ask the bidder for clarification of bids. The request for clarification and the response shall be in writing, but no change in prices or substance of the tender shall be sought, offered or

permitted.

- 19. The Central Purchase Committee / Purchase Committee constituted for the purpose reserves the right to accept or reject any or all the bids or negotiate on any of the tender conditions/ items and to annul the bidding process and reject all the bids at any time prior to placement of order without assigning any reason thereto and without any obligation to inform the affected bidders.
- 20. The bidder should possess minimum 2 years experience in direct supply installation and maintenance of Cameras and other equipments related to cameras. Proof of direct dealership details (Manufacture's authorization letter/dealership certificate for supply of equipments) along with contact details of minimum 3 prime customers to who the equipments has been supplied by the vender are required to be attached with quotation.
- 21. The quotee shall append a certificate with the quotation/tender that the firm has not been debarred / blacklisted for any reason / period by any Central/State Govt. Dept. / University / PSU etc. If so, particulars of the same may be furnished. Concealment of facts shall not only lead to cancellation of the order, but may also warrant legal action.
- 22. The dispute, if any, shall be subject to the jurisdiction of Courts at Rohtak. Any other jurisdiction mentioned in the quotation or invoices or any other document shall have no legal sanctity.
- 23. Terms and conditions printed on Quotation of the firm, if any, shall not be binding on the university, except those mentioned specifically on the order, and acceptance of the order shall be construed as the firm's complete agreement to all the terms and conditions contained in the order and the tender notice.
- 24. A three years on-site warranty on the item will be required. Beyond these 3 years, specify the post warranty comprehensive annual maintenance charges for upto 2years.
- 25. Installation of the entire CCTV Intelligent Surveillance System shall be the responsibility of the Firm.
- 26. PVC conduit pipe and CAT 5/6 cable will be supplied by the Library.
