Sealed tenders for “Tender for Sculpture” addressed to the Registrar, MDU, Rohtak are invited from reputed firms / Sculptors who have carried out minimum three similar works in Government / Semi Government Departments for the fabrication, supply and installation of a standing Bronze Sculpture of Ch. Ranbir Singh (12 feet height) alongwith earnest money of Rs. 30,000/- in the shape of a Demand Draft in favour of Executive Engineer, M.D.U., Rohtak. Tender form and DNIT containing detailed terms and conditions may be purchased on payment of Rs. 2,000/- in cash from the office of the Executive Engineer on any working day upto 12:00 Noon till 15.07.2011. Tenders will be received upto 2:00 P.M. on 15.07.2011 and opened at 2:30 P.M. on same day in the Committee Room of Vice-Chancellor office in the presence of representative(s) of firm(s) /Sculptors whosoever will be present. Specifications, terms and conditions of Fabrication, supply and installation of sculpture of Ch. Ranbir Singh in MDU, Rohtak

1. Tender will be given to those sculptors who have completed at least three similar types of sculptures in Government /Semi Government Department. A certificate signed by the concerned Department will be submitted at the time of purchase of tender alongwith photos of sculptures.
2. The medium of sculpture should be in Bronze. The composition of the Bronze should be as Copper 85%, Tin5%, Lead 5%, and Zinc 5%.
3. **Size standing:** 12 feet.
4. **Weight:** 1200 to 1400 Kilograms
5. **Thickness:** Thickness of the metal layer (Bronze) should not be less than 10mm on sculpture.
6. **Time period:** The whole assignment should be completed in the duration of three months only from date of issue of the allotment.
7. The miniature model (in clay/ plaster of paris) of Ch. Ranbir Singh will be provided by the designated Agency(ies) within five days after opening of tender and work will be allotted after judging the miniature model and negotiations of rates by the Committee. Photo of Ch Ranbir Singh will be provided alongwith DNIT/Tender form.
8. **Contract of the Assignment:** The contract of the above said assignment will only be given to either a creative and reputed guild of sculptor or an individual creative and reputed sculptor.
9. **Approval:** The Committee will approve the required size models (in clay/ plaster of paris) of the Sculpture before final casting in their workshop / studio.

10. **The mode of the payment:** The mode of the payment will be as under:

- (a) 25% payment of awarded cost will be released after approval of required size model (in clay / plaster of paris) by the Committee.
- (b) 50% payment of the awarded cost will be released after receipt of the approved sculpture in MDU Campus.
- (c) Balance 25% payment will be released after installation of the sculpture at site in all respect as per satisfaction of the Committee.

11. **Pedestal:** The pedestal will be constructed by the Maharshi Dayanand University as per the requirement of the guild of sculptors / an individual sculptor. The design and drawing of the pedestal will be provided by the allotted Agency within tend days after allotment of work.
