Quotations received after due date and time shall be rejected outrightly. The University shall not be responsible for any postal or transit delay. Quotations shall be **opened in the Committee Room of Vivekananda Library, M.D. University, Rohtak on 02.09.2013 at 12.30 p.m.** If 02.09.2013 is declared as a holiday due to some exigencies, the quotations shall be opened on the next working day at the same time and venue. The quotees or their authorized representative, at their own cost, shall be allowed to be present at the time of opening of quotations.
