Sub: Minutes of the meeting of the Committee held on 12.5.2016

Sir/Madam,

I am directed to inform you that the Admission Committee vide

Resolution No.11 & 16 of its meeting held on 12-05-2016 resolved as under:-

11. Considered the following Clause No.3 appearing at page 25 of the Prospectus for the Session 2015-16 with regard to admission to 2<sup>nd</sup> P.G. Course in the University Teaching Departments/College for the Session 2016-17:-

"After passing any post-graduate examination from any University/ College, no candidate shall be allowed admission in any P.G. Course in any of the Department/College. Due to limited facilities in the hostels, admissions in the hostels shall be allowed only once at the time of 1<sup>st</sup> entry in the University and no readmission shall be allowed after completing the course."

## RESOLVED THAT THE CIAUSE-3 BE AMENDED AS UNDER:-

"After passing any post-graduate examination from any University/ College, candidates shall be allowed admission in any P.G. Course in any of the Department/College. However, no hostel facilities shall be provided to them as admission in the hostel shall be allowed only once at the time of 1<sup>st</sup> entry in the University/affiliated Colleges running P.G. Courses."

- 16. i) There shall be no negative marking in entrance test for all the courses.
  - ii) The candidate must secure at least 35% (5% relaxation to SC candidates of Haryana only) in the entrance test to be eligible for admission to those courses for which admissions are made through entrance test.
  - iii) If seats remain vacant, the above requirement of marks can be relaxed upto 10% marks by the Vice-Chancellor on the recommendations of the Head of the Department concerned.
  - iv) No further relaxation in any case shall be permissible.

The above information has also been got incorporated in the Prospectus 2016-17. Further necessary action may be taken accordingly.
