I am directed to invite your kind attention to the Government instruction issued vide No. 22/10/2014-IGSIII, dated 15.07.2014 and notifications issued by Welfare of Scheduled Castes and Backward Classes Department vide No. 59 SW(I)- 2013, dated 23.01.2013 and No. 733 SW (I)-2013, dated 27.09.2013 vide which it was decided to grant 10% reservation to Economically Backward Persons belonging to General Category in Jobs under Government/ Government Undertakings & Local Bodies as well as in admission in Haryana Government/ Government aided educational/ technical/ Professional institutions.

The Hon'ble Punjab and Haryana High Court vide orders dated 22.09.2016 passed in CWP No. 18514 of 2016- title as Kalindi Vashishtha Vs State of Haryana and others has stayed the operation of the above referred instructions dated 23.01.2013 and 27.09.2013.
