### Background of the Conference

Gender inequality is one of the most crucial discrimination in many societies. Females always had lower status than males, but the extent of the gap between the sexes varies across cultures and time. Kofi Annan stated that "Gender equality is more than a goal in itself. It is a precondition of meeting the challenges of reducing poverty, promoting sustainable development and building good governance".

In Indian context large inequality exists in socio-economic environment between male and female. Gender disparity exists right from the birth of the child with infant mortality and morbidity rates higher for female than that of males due to parents' overlook towards female infant and the discrimination and it carry on as the child grows older in form of food and poor nutritive diet, medical care, less schooling opportunities for girls compare to boys. Even in the employment market women face discrimination too mostly in the form of inferior wages.

Particularly in case of Haryana women have constantly been treated as secondary citizen. This discrimination is even very much higher among dalit women. Women belonging to lower caste have had lower status in social, economic and political field than that of upper caste. This Conference is aimed to look into gender inequality in a comparative manner from the social, economic and political angle such as sex ratio, education, health, violence against women, work participation rate, role of women in decision making and empowerment. It intends to analyze and to understand how women and men are differentially placed in the class system in Haryana. It will discuss how do gender, race, class, contribute to the formation of social identities? What measures have been taken, in the past and the present, in order to prevent discrimination and exclusion? How do academic, cultural, journalistic, and policy-making institutions respond to these societal challenges? explore the ways that femininity and masculinity affect an individual's thought process

and discuss the issue of gender as a social determinant of socio-economic inequality between men and women, why men and women have different expectations and roles imposed on them by society and that has adverse impact on women from the point of view of human rights with particular reference to Haryana

In the backdrop of above facts, Chaudhry Ranbir Singh Institute of Social & Economic Change M.D.University, Rohtak is going to organize a National Conference on "Gender and Society with Specific Reference to Haryana".
