- The selected bidder will be required to supply, install & Configure the items within 2-4 weeks from the date of issue of Purchase Order.
- No advance payment shall be made; any offer linked with advance payment is likely to be ignored/rejected.

- i. A penalty of 0.5% of the total order value will be imposed per week for late delivery.
- j. A three year Onsite OEM warranty on the all equipment mentioned above After completion of OEM warranty, AMC from OEM for next two years (year 4<sup>th</sup> & 5<sup>th</sup>) will be required.
- k. The bidder should possess minimum 5 Years' experience in direct supply, installation, testing and commissioning of similar items to the Govt./Public Sector/Reputed Institutions. Proof of direct dealership details i.e. OEM authorization letter/dealership certificate for supply along with 3 Prime Customers contact details and photocopies of Purchase Order and/or installation report, to whom the similar items have been supplied by the Tenderers, is required to be submitted along with the Technical Bid.
- l. Fax /Telex and incomplete offers will be summarily rejected. The University reserves the right to accept or reject any or all bids received at its absolute discretion without assigning any reasons whatsoever. Late bids will not be considered. Any tender received after deadline for submission of Tender prescribed by the MD University Rohtak shall be rejected.
- m. The bidders must quote rates and other terms and conditions for all the equipment's/items failing which tender will be rejected. Total cost of the Quotation will be one of the important deciding factor while deciding the Quotation in favor or against any bidder.
- n. The bids of the bidders who do not fulfill the minimum eligibility criteria will not be considered.
- o. It is here by certified that the firm has not been debarred/blacklisted for any reason/period by any central/state Govt. department/University/PSU etc
- p. The offers quoted without AMC for 4<sup>th</sup> & 5<sup>th</sup> years may not be considered.
- q. The warranty period will be reckoned from the date of installation and acceptance of the items by MD University, Rohtak.
- r. Bidder may visit the site before summiting their Bids.
- s. Sealed tenders/quotations should reach the office of the undersigned by name on/before 05/04/2016 quoting our reference and due date of opening on the envelope. The quotations will be opened at 4.00 pm on the same day.
- t. The acceptance of goods/services is subject to the approval of Inspection Committee.
- u. Dispute, if any, will be subject to Rohtak Jurisdiction.
- v. The University reserves the right to reject any or all quotations/tenders without assigning any reason thereof.
- w. If your rates are approved by DGS&D and other Central/State Agency, the same must be mentioned and the copy of the contract be attached.
