Sub: **Admissions against Sports Quota Seats**

Sir/Madam,

I am directed to inform you that due to oversight the following old provision has been mentioned at pages 19 and 20 in the Centralized Online Admissions Prospectus for the Session 2017-18:-

Clause-viii page-19

- (I) The candidate better in sports will be admitted as per merit decided by the committee consisting of Dean, Faculty of Education, HOD Physical Education, Director Sports, Dy. Director Sports and a Coach of the concerned Game in which the students is taking the admission.

Clause-8 page-20

The application form received for outstanding Sports Quota seat upto last date of applying for admission, shall be sent to the Dean, Faculty of Education within three days after the 3rd counseling of the concerned Department. Thereafter, the Committee will recommend his/her case for admission within ten days after the 3rd counseling. No late fee shall be charged from such candidates.

In the Prospectus of except Centralized Online Admission, the correct provision has been mentioned at Pages 32 and 34 regarding Sports Quota seats which is applicable to all courses and are as under:-

Clause-viii page 32

- (II) The candidate better in sports will be admitted as per merit decided by the Admission Committee of the concerned Department/College. However, the Director Sports will guide the Admission Committee with regard to checking the genuineness of the Certificates/merit

Clause-9 page 34

The application form received for outstanding Sports Quota seat(s) upto last date of applying for admission, shall be sent to the Director Sports within three days after the 3rd counseling of the concerned Department, if required any clarification/guidance. Thereafter, the Admission Committee will decide the case for admission within ten days after the 3rd counseling. No late fee shall be charged from such candidates.

In this connection, it is intimated that the provision at Sr. No.II as mentioned above may be followed to all the Courses being run in the University Teaching Departments and UILMS,Gurugram during the Session 2017-18 for the purpose of admission against Sports Quota Seats.

Further, necessary action in the matter may be taken, accordingly.
