  - 1. The Committee considered the requests of Director, IHTM, Head, Department of Computer Science & Applications and Director, Centre for Bio-Informatics for filling up the vacant /left over seat (s) by inviting fresh applications. The Committee deliberated upon the issue at length and recommended that all the Heads of the Departments be permitted to fill up the vacant/left over seats by conducting physical counselling on 17.8.2017. For this purpose, the admission portal be re-opened from 6.8.2017 to 14.8.2017 so as to enable the candidates to apply online application for admission for the Department where the existing merit list has been exhausted and seats are vacant. The concerned HODs, i.e. the Departments where fresh applications are to be invited, will inform the Director, UCC the names of the programmes alongwith number of vacant seats. All the candidates are required to submit computer generated application form upto 16.08.2017 (2.00 p.m.) with all required documents, if they wish to seek admission to the programmes for which the admissions are to be made on the basis of academic merit.
  - 2. The concerned Department shall prepare the merit list on the basis of marks in the qualifying examination or score of entrance test whichever is applicable. The merit list will be displayed on 16<sup>th</sup> August 2017 by the Departments for which the fresh applications are invited. The counselling shall take place on 17<sup>th</sup> August 2017. The candidates will be required to pay the fee on the same day.
  - 3. The detailed instructions already circulated for physical counselling to be held on 5.8.2017 be also followed for the counselling to be held on 17.8.2017.
