The Committee considered the request of the students for extension of last date for admission to various UG/PG Courses in detail for the Session 2017-18 and recommends as under:

- 1. Since the admission to various UG/PG Courses in affiliated Colleges have been made by the State Government through online, no date be extended for fresh admission to First Semester of B.A/B.Sc./Com etc. and M.A./M.Sc./M.Com etc. for the session 2017-18.
- 2. Last date for admission to 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> Semester as the case may be in respect of eligible students for various courses being run in the UTDs/UILMS and affiliated Colleges except Engineering Courses be extended upto 28.9.2017 with late fee of Rs.3000/- (the late fee of Rs.3000/- to be remitted to the University by the College/Institute alongwith registration return upto 03.10.2017). If the number of teaching days falls short, it shall be the responsibility of the Director/Principal/Head of the Department concerned to make good the loss by taking extra classes.
- 3. The Committee considered the requests of various students who could not submit the result of proof of passing the qualifying examination i.e. BA/B.Sc./B.Com etc. (final year) upto 31.08.2017, be allowed to submit the same upto 28.09.2017 and their admissions to the MA/M.Sc./M.Com/M.P.Ed./LL.M/MBA etc. in the University Teaching Departments and ULIMS, Gurugram be regularized, if their names have been struck off by the concerned HODs for non-submission of result of qualifying examination.

- 4. Last date for admission to various courses i.e. MA/M.Sc./M.Com/M.P.Ed/LLM/.MBA etc. being run by the **UTDs** and UILMS be extended upto 28.9.2017 for making admission against vacant seats by the concerned HOD Department with late fee of Rs.3000/-as per merit list already available with the Department. The candidates shall be required to make their attendance in the respective Departments from 9.00 a.m. to 11.00 a.m. on the said date 1.2.28.9.2017
- Keeping in view the number of applicants on higher side, the Committee recommends that two Committees/Interview Boards be formed by the HOD (Commerce) for conducting interview of the eligible candidates for admission to Ph.D Programme. If the interviews of the candidates are not completed on 9.10.2017 itself, the same be conducted upto forenoon of 10<sup>th</sup> October 2017.
- 6. The committee considered the request of various candidates for extension of last date of submission of Ph.D Programmes and recommends that the date be not extended as there was no technical error in the University portal during the period of submission of application form for the course as informed by the Director, University Computer Centre on telephone today i.e. 22.9.2017.
- 7. The entrance test of Ph.D in Tourism Management be conducted on 4.10.2017 at 9-15 a.m. to 10-30 a.m. instead of 3.10.2017. The candidates who have already applied for admission to Ph.D Programme in IHTM may appear in the entrance test as per their choice. Number of seats for Hotel and Tourism Management be read as 2 and 3 respectively as requested by the Director, IHTM. Necessary information may be displayed on the University Website as well as on the Notice Board of IHTM and Press Note may also be released accordingly.
