Sub: **Minutes of the meeting of the Grievance Redressal Committee Held on 25.7.2017 at 4.00 P.M. in the office of Dean Academic Affairs**

Sir,

I am directed to inform you that a meeting of Redressal Grievance Committee under the Chairmanship of Dean Academic Affairs was held on 25.7.2017 and it was recommended as under : -

- i) Admission portal for admission to MCA 3-Year Course (1stSemester) and (M.Sc. Computer Science 1st Semester) be made live for seeking applications from 27.7.2017 to 1.8.2017 (11.59 p.m.). The applicants will be required to submit the computer generated copy along-with proof of application fee paid and all required documents latest by 2.8.2017 upto 2.00 p.m. for the purpose of filling up the vacant seats for these courses. The candidates who have already applied online for these programmes need not to apply again and no application fee will be charged from them. However, they have to submit their written request on a plain paper along-with their computer generated copy duly signed and all required documents upto 1.8.2017 to Head, Department of Computer Science & Applications. Position of vacant seats be also displayed on the Notice Board of the Department and on the University Website. The admissions to these courses be made by the Head, Department of Computer Science & Applications on the basis of merit on 3.8.2017. The candidates will be required to pay the prescribed fee on the same day.
- ii) In view of total 415 applications received against 120 seats for admission to 5-Year Integrated MBA Course and after third counselling, the admissions have been made upto the rank of 310. The Committee considered the request of Director, IMSAR and recommended that 10% seats (total 12 seats) be increased for the session 2017-18 only. Reservation of seats as mentioned in the prospectus be also followed by the Institute and the admissions be made on the basis of merit already available with the Institute.

The above recommendations of the Committee have been approved by the Vice-Chancellor.

However, the recommendations at sr. no. (ii) above have been approved in anticipation approval of Admission Committee.

Further necessary action in the matter may be taken, accordingly.
