ADMISSION TEST FOR INTEGRATED MBA (IMEA), BBA, BCA, BFA, etc.  
(Academic Year 2017-2018)**

Respected Sir,

AIMA has been administering Under Graduate Aptitude Test (UGAT) since 1996 on All India Level as a common admission test to facilitate institutes/colleges/university departments imparting above program with a single test which is economical and credible. The test is being administered every year in the month of May.

Unlike other tests, under the scheme of UGAT; Institutes can participate by including their profiles in the UGAT Bulletin. This enhances the visibility of institutes among all stakeholders. Besides, it enables the institutes to avail a range of value added services as given in the Guidelines for Institutes. Separate UGAT Bulletins are brought out for every administration of UGAT, and every candidate is provided with a copy of Bulletin (Print) with UGAT Registration Form; whereby the visibility of the participating institutes is enhanced amongst potential candidates.

The candidates are given the option to indicate any five of the participating institutes in the registration form. The data and score of the candidates are provided to the institutes indicated by the candidates. In addition, candidates are provided with individual score card, which can be produced to any Institute. Institutes can decide on the cut-off score for admission or for further screening based on the number of seats available.

The Institutes can now confirm their participation for the forthcoming administration of UGAT 2017, which is scheduled on 13 May 2017 (Saturday). And, we have planned to bring out the UGAT bulletin for it by February 2017.

We are enclosing the "Guidelines and Consent Form" to provide guidance for your participation in the UGAT 2017 administration. Kindly peruse the enclosed document and submit duly filled Consent form for your institute's participation so as to reach us latest by 31 January 2017.
