Sub : **Minutes of the meeting of the Faculty of Law held on 22.02.2017 – Age restriction in LL.B Courses and Discontinuation of Evening Classes from the session 2017-18.**

Sir,

I am directed to inform you that the Vice-Chancellor has been pleased to approve the following recommendations of the Faculty of Law of its meeting held on 22.02.2017 (Based on the recommendations of the BOS in Law held on 15.02.2017) in anticipation of approval of Academic Council/Executive Council :-

1. **Age on admission:**
 - (a) Subject to the condition stipulated by a University on this behalf and the high degree of professional commitment required, the maximum age for seeking admission into a stream of integrated Bachelor of Law degree program, is limited to **twenty years in case of general category of applicants and to twenty two years in case of applicants from SC, ST and other Backward communities.**
 - (b) Subject to the condition stipulated by a University, and the general social condition of the applicants seeking legal education belatedly, the maximum age for seeking admission into a stream of Three Year Bachelor Degree Course in Law, is limited to **thirty years with right of the University to give concession of five further years for the applicants belonging to SC or ST or any other Backward Community.**

2. **Discontinuation of Evening Classes**

The committee constituted for the purpose of implementation of guidelines of BCI issued vide letter No. 1761/2016 (LE/Evening) dated 30.11.2016 regarding discontinuation of Evening classes from the session 2017-18 discussed the matter threadbare. The committee was of the opinion that in view of the guidelines issued by the BCI it will be illegal to conduct classes in evening shift. Therefore, it was resolved unanimously that evening word be scraped from the prospectus and 2nd shift be started from 02.00 p.m. to 07.00 p.m. for running LL.B – 3 Year course. This decision of the committee was placed before the Departmental Committee in its meeting held on 10.01.2017 and the above decision of the committee was approved. The decision of Departmental Committee was placed before BOS in its meeting held on 15.02.2017 and the same was approved by BOS also.

In view of the above, the Vice-Chancellor has also passed orders that the Prospectus for the session 2017-18 be prepared and amendments in the concerned Clauses of the Ordinances of the LL.B - 3 year and LL.B - 5 year Integrated Course be made accordingly.
