

The Committee after detailed discussions unanimously resolved as under:-

1. URS Ordinance is to be amended in accordance with the new Ph.D Ordinance 2016. The following Sub Committee shall prepare a draft for the same for consideration of the Committee:-
 - a) Prof. Gulshan Taneja, Director, IQAC
 - b) Prof. Rahul Rishi, Dean, Faculty of Engg. & Tech
2. Regarding M.Phil issue, the Committee decided to stick to the provisions as contained on page 15 of the prospectus without any other interpretation. The authenticated Certificate regarding evaluation of M.Phil Dissertation (upto 29th Jan 2017) shall be issued by the Secrecy Branch.
3. The JRF candidates, who have JRF Certificate with validity upto 30-01-2017 will be awarded 20 marks, otherwise, the candidate will be treated as NET qualified and shall be awarded 15 marks.
4. The candidates having GATE and any other similar test Certificate on which the duration of validity is mentioned, shall be considered for award of marks as notified, provided the validity exists on the day of display of merit list.
5. The Committee considered the request of Prof. Mehtab Singh in the Department of Geography and resolved that 4(four) Ph.D seats in Ph. D programme in the Department of Geography be allowed in addition to the already notified seats.
6. The request of Kusum Chahal was considered and was not acceded to.
