

MINUTES OF THE MEETING OF THE COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR TO CONSIDER THE ISSUE REGARDING AWARD OF UNIVERSITY RESEARCH SCHOLARSHIP IN Ph.D. PROGRAMME FOR THE SESSION 2017-18

The following were present:

On the receipt of various queries from the University Teaching Department regarding University Research Scholarship, the Committee deliberated at length over the following existing provision given at Page No. 13 of Prospectus for admission to Ph.D. Programme for the session 2017-18:

*Options for award of scholarship shall be filled up in the application form and may be exercised by the candidate at the time of interview/counselling. If a candidate has not opted for award of University Research Scholarship, he/she will not be awarded the Scholarship. The merit list prepared for admission to Ph.D. Programme will also be applicable for award of University Research Scholarship. University Research Scholarship will be awarded **to the candidates higher in merit and who are eligible for registration to Ph.D. Programme.***

The Committee, after due deliberations on the issue, resolved the following:

While recommending the candidates for award of URS, the eligibility for registration to Ph.D. programme be read as under:

- i) The candidates who have been admitted to Ph.D. programme opting for the award of URS for the session 2017-18 and have already completed Ph.D. course work/M.Phil./Pre.Ph.D. Course at the time of admission may be awarded the University Research Scholarship from the date of joining as URS, if selected on merit.
- ii) In case seats still remain vacant, the URS may be awarded on merit to those candidates also who are admitted to Ph.D. programme but not eligible for registration on the date of admission. However, the URS to such candidates shall be released from the date they become eligible for Ph.D. registration.

The H.O.D.s/Directors of the University Teaching Department may ensure that the above mentioned provision be abided by in letter and spirit.


