**REVISED NOTIFICATION**

In continuation of this office Notification issued vide No. Endst. No. MDU/R-1/AE-2/2017/27973-28122 Dated: 25.07.2017 and on the request of various groups of students, the Vice-Chancellor, in anticipation of approval of the Academic Council, has also accorded permission for granting Special Chance to all such students who were registered in their concerned courses (B.A /B.Sc/B.Com & M.A/M.Sc/ M.Com ) in academic session 2000 to 2011 but could not complete their respective courses with in the admissible period/chances on the following terms and conditions :-

- i. **For this special chance only those students shall be allowed to appear who have not availed any special chance earlier, as such type of chance was given in 2014 for the above said courses from the Academic Session 1990 onwards.**
- ii. This special chance shall only be admissible to the students of BA/B.Sc./B.Com and M.A./M.Sc./M.Com. Courses who could not complete their degree and were registered for this course for the period from **2000 to 2011**.
- iii. Those students who were registered for BA/B.Sc./B.Com and M.A./M.Sc./M.Com. Courses after the Academic session 2011 shall not be entitled for this special chance being the reason that they are having admissible chance(s)
- iv. For this special chance, a fee of Rs. 10,000/- each examination i.e. Rs. 10,000 per semester/Annual depending upon the Scheme of Examination, shall be chargeable.
- v. The special chance is admissible to complete the degree for the students who have reappear in one or more papers and also for improvement of marks/division.
- vi. For this Special Exam, Centre(s) of examinations shall be at Rohtak only.
- vii. The examinations for this special chance shall be got conducted tentatively in the month of August/September, 2017 as per the existing/current syllabi according to each course.

The examination form along with fee shall be filed up through online mode **latest by 28.08.2017**. No examination form will be entertained/accepted after the cut-off date as 28.08.2017. The schedule of examination/declaration of result will depend on administrative requirements and the students will have no claim for early conduct of examination as well as declaration of results. If any **INELIGIBLE** candidate submit his/her online examination form, they will be responsible for that and the examination fee will not be refunded to such students.
