NOTIFICATION

It is notified for the information of all concerned that on the request of students, the Vice-Chancellor, in anticipation of the approval of the Academic Council, has accorded permission to grant a special chance to the students, who were registered in LLB/LLM(Annual Scheme only) in the year 2000 to 2011 through regular mode but could not complete their respective courses within admissible chances which would be subject to fulfilment of the following conditions:-

1. The special chance shall only be admissible to the students of LLB/LLM (Annual Scheme only) who could not complete their degree and were registered for this course for the period from 2000 to 2011.
2. Those students who were registered for LLB/LLM (Annual Scheme only) after the Academic session 2011 shall not be entitled for this special chance being the reason that they are having admissible chance(s).
3. For this special chance, a fee of Rs. 10000/- each year i.e. Rs. 10,000/- depending upon the Scheme of Examination, shall be chargeable.
4. The special chance is admissible to complete the degree for the students who have reappear in one or more papers.
5. For this special chance, Centre(s) of examinations shall be at Rohtak only.
6. The examination for this special chance shall be got conducted tentatively in the month of October, 2017 as per the existing/current syllabi according to each course.

The examination form alongwith fee shall be filled up through online mode latest by 26.9.2017. No examination form will be entertained/accepted after the cut-off date i.e. 26.9.2017. The schedule of examination/declaration of result will depend on the administrative requirements and the students will have no claim for early conduct of examination as well as declaration of results. If any INELIGIBLE candidate submits his/her online examination form, he/she himself/herself will be responsible for that and the examination fee will not be refunded to such students.
