## NOTIFICATION

- The examination for this special chance shall be got conducted tentatively in the month of October, 2017 as per the existing/current syllabi according to each course.

The examination form alongwith fee shall be filled up through online mode latest by 26.9.2017. No examination form will be entertained/accepted after the cut-off date i.e. 26.9.2017. The schedule of examination/declaration of result will depend on the administrative requirements and the students will have no claim for early conduct of examination as well as declaration of results. If any INELIGIBLE candidate submits his/her online examination form, he/she himself/herself will be responsible for that and the examination fee will not be refunded to such students.
