9. Child Labour Issue & Child Labour (Prohibition and Regulation) Act, 1986
10. SC/ST Issues & Scheduled Caste and Schedule Tribe (Prevention of Atrocities) Act, 1989, Civil Liberties Act, 1988 & the Forest Rights Act, 2006.
