**27. Grant of Provisional affiliation for starting of M.Sc.(Physics) & M.Sc.(Chemistry) 1<sup>st</sup> year courses at Suraj Degree College, Sector-75, Gurugram**

Rohtak regarding grant of Provisional affiliation for starting of M.Sc.(Physics) & M.Sc.(Chemistry) 1<sup>st</sup> year courses directly w.e.f the session 2018-19 at Suraj Degree College, Sector-75, Gurugram on the basis of request of the Principal concerned and N.O.C issued by the State Govt. bearing Memo No. 07/02-2016 C-II(2) dated 4.05.2018 (**Annexure A/32 page 239, already circulated**) by relaxing the condition that "affiliation for P.G. Courses be granted in new Colleges only after passing out the 1<sup>st</sup> batch(es)" as has been resolved by the Executive Council by its Reso. No 20 dated 12.08.2014 (**Annexure A/33 page 240, already circulated**).
