Sub - Special Chance for BCA/B.Ed (Regular) Course Students to Clear the Degree

Dear Sir/Madam,

On the request of the students, the Vice-Chancellor has accorded permission for grant of special chance to all the eligible students of BCA and B.Ed (Regular) who enrolled themselves for BCA course during the period from 2003 to 2011 and B.Ed (Regular) course from 2009 to 2013 and could not clear the degree within the admissible chances. This special chance shall be admissible to the students, fulfilling the following conditions/criteria:-

- i. This special chance shall only be admissible to the students of BCA (Regular) who could not complete their degree and were registered for this course for the period from 2003 to 2011 and B.Ed (Regular) courses from 2009 to 2013.
- ii. The students who still have admissible chance(s) to clear the degree, shall not be entitled for this special chance i.e. the students enrolled from the session 2012 of BCA and B.Ed Regular of 2014 onward shall not be eligible for the special chance.
- iii. For this special chance, a fee of Rs 15000/- per semester shall be chargeable.
- iv. The special chance is admissible only to complete the degree for the students who have reappear in one or more papers and not for Improvement of marks/division.
- v. For this special exam the centre(s) of examination shall be at Rohtak only.
- vi. The examination for this Special Chance shall be got conducted tentatively in July 18.

The examination form alongwith fee shall be filled up through online mode upto 15.06.2018 only from the portal of college where student get themselves enrolled. No examination form shall be entertained/accepted after the cut off date as 15.06.2018. The schedule of examination/declaration of result will depend on administrative requirements and the students will have no claim for early conduct of examination as well as declaration of results. If any INELIGIBLE candidate submits his/her online examination form, he/she will be responsible for that and the examination fees will not be refunded to such students.
